Over the years, no matter how much we impress on our clients to come back to us if there are any problems, we have experienced a couple of instances where the family's circumstances have changed and we have not been given the opportunity to assist one of our puppies to be suitably rehomed. While we do not believe we have the need or right to have control over puppy once it has been adopted out, we do care enough to want to assist if circumstances change and ensure that the little people we've brought into the world have the best of opportunities for a lovely life. Therefore, it has been necessary to require a legally binding, written and signed agreement from our families to cover our rights as caring and responsible breeders and to continue to do the best we can for our puppies should family circumstances change or a situation prove unsuitable.
